CLOSED SESSION – PROPERTY ACQUISITION

RESOLVED, that the board enter into closed session to discuss property acquisition.

RESOLVED, that board approves the Real Estate Purchase Agreement for vacant property commonly known as the Orchards – Phase II, at a purchase price of \$95,000, plus taxes due on July 1, 2013 and thereafter and appropriate closing costs and authorizes the President and Secretary to sign the Agreement, and

BE IT FURTHER RESOLVED, that the source of funds for the transaction be derived from the following accounts: Capital Outlay, Land, #248-000.00-971.000 (a portion of which shall be

transferred as revenue from the 2013 capital improvements bond issue), \$95,000.00 and DDA Miscellaneous, #248-000.00-956, approximately \$2,500 (for taxes due July 1, 2013 or thereafter), and

BE IT FURTHER RESOLVED, that the board authorizes its Executive Director to take the steps necessary to finalize the closing on property acquisition and to make minor, non-substantive changes to the Agreement, and

BE IT FURTHER RESOLVED, that the board authorizes the President and/or Secretary to execute documents at closing.
