<p>Background:</p> <p>6 p.m. - James Dilts: The vacancy on the Emergency Preparedness Committee is for an alternate, this is a 3-year term through Feb. 1, 2028. The Emergency Preparedness Committee meetings are held on the first Monday of each month at 5 p.m. at Farmington Hills City Hall, excluding February, April, August, October and December.</p> <p>6:15 p.m. – Sarah Adair: Sarah indicated interest in both the Community Health Commission and Commission for Children, Youth and Family. Both have vacancies. If only appointed to one commission, she said her preference would be the Community Health Commission. The Community Health Commission vacancy is an alternate’s position, and is a 3-year term through Dec. 31, 2027. Community Health meetings are held on the third Wednesday of each month at 6:30 p.m. at Farmington Hills City Hall, excluding July, August and December. The Commission on Children, Youth and Families is a 3-year term, also through Dec. 31, 2027. CYF meets the first Thursday of each month at 6 PM in the Farmington Hills City Hall.</p> <p>6:30 p.m. – Heidi Cook: The vacancy on the Beautification is a 3-year term through June 30, 2027. The Beautification Committee meets the first Monday of the month at 7 p.m., currently at Blue Hat Coffee.</p>
